3. Managed futures update

Transtrend Diversified Fund, LLC, one of the System's Global Asset Allocation investments managed by Robeco Investment Management, provided a portfolio review to the IAC on January 7, 2014. The Board also discussed and reviewed the Transtrend investment at the January 9, 2014, Board meeting. After deliberation, the Board requested staff to research the managed futures strategy and provide an informational report.

Staff presented an introduction and overview of the Global Asset Allocation asset class and managed futures strategies. Discussion also included managed futures basics, relative performance, and comparison to other commodity strategies.
