Dear Gary:

I am now in receipt of your letter to my attention of October 2, 2002, regarding Registration of Domain Names Infringing DPFPS's Trademark Rights. In view of the many issues and concerns set-forth in your letter, it now seems prudent to include with our proposed modification to our August 9, 2002, Agreement, an additional provision stating that the Pension System understands that CFOpros has registered and now owns the dpfps.org and dpfps.com domain names, and that the Pension System acknowledges CFOpros right to the registration, ownership, and exclusive use of the dpfps.org and dpfps.com domain names. Further, the Pension System and its Board of Trustees agree to waive any and all rights under common law, state statutory law, and the Lanham Act, to any and all claims (past, present and future) against CFOpros for the registration and use of dpfps.com and dpfps.org including (but no limited to) trademark infringement, dilution, unfair competition, and deceptive trade practices, and the Pension System further agrees not to pursue ownership of same except by negotiated purchase and willing agreement by the parties.

Clearly, any change to our Agreement of August 9, 2002, should now include written assurances from the Pension System that effectively "permanently reverse" all issues noted in your letter of October 2, 2002. While the addition of these changes are believed consistent with our discussion of last Friday, I remain concerned by the harshness of your letter, and will need the aforementioned written assurances from your client in order to proceed with any amendment to our current Agreement.

Separately, in an effort to avoid any potential issues related to our Agreement of August 9, 2002, my intention as earlier discussed is to exclude certain properties believed owned by the Dallas Police & Fire Pension System from a soon-to-be publication of events regarding the proposed Victory Project and other related matters of concern. I have listed below the properties believed owned by the Pension System, and would appreciate a letter confirming ownership by the Dallas Police & Fire Pension System or its Pension Plan in order to avoid publication.
